Terms and Conditions for Made For Trade Windows Ltd.

Please read these Terms and Conditions ("Agreement") carefully before placing an order with Made For Trade Windows Ltd. This Agreement sets forth the legally binding terms and conditions for the purchase and collection of uPVC windows and doors.

#### 1. Acceptance of Terms

By placing an order with Made For Trade Windows Ltd., you acknowledge and agree to be bound by these Terms and Conditions. If you do not agree with any part of this Agreement, please do not place an order.

#### 2. Order Process

a. Specification and Quotation: It is the responsibility of the customer to provide accurate specifications for the uPVC windows and doors required. Made For Trade Windows Ltd. does not offer survey or installation services. Customers are responsible for checking the full specification on our quotations to ensure that we have accurately interpreted the sizes and specifications they have provided.

b. Acceptance: Orders are subject to acceptance by Made For Trade Windows Ltd. and will be confirmed through an order acknowledgement.

#### 3. Collection and Storage

a. Collection: All orders must be collected by the customer on the date specified in their order acknowledgement. It is the customer's responsibility to arrange suitable transportation for the collected goods.

b. Storage Charges: If an order is not collected within 3 days of the date shown on the order acknowledgement, storage charges may apply. The storage charges will be communicated to the customer, and payment for the charges must be made before the goods can be collected.

c. Disposal: If an order is not collected within 6 weeks of the collection date or if the storage charges remain unpaid after the storage period of 6 weeks, Made For Trade Windows Ltd. reserves the right to dispose of the goods at their discretion without any further liability.

#### 4. Pricing and Payment

a. Pricing: The pricing for uPVC windows and doors will be provided to the customer upon request. Prices are subject to change without prior notice.

b. Payment: Full payment for the ordered goods is required before collection. Made For Trade Windows Ltd. accepts payment through approved methods, as specified on our invoices or provided by our customer service team.

#### 5. Product Warranty

a. Limited Warranty: Made For Trade Windows Ltd. provides a limited warranty on uPVC windows and doors for defects in materials and workmanship. The warranty period and terms are as specified in our separate warranty policy.

b. Exclusions: The warranty does not cover damages resulting from improper handling, installation, maintenance, accidents, natural disasters, or unauthorized modifications or repairs.

## 6. Limitation of Liability

- a. Made For Trade Windows Ltd. shall not be liable for any direct, indirect, incidental, consequential, or special damages arising out of or in connection with the purchase, collection, or use of the uPVC windows and doors.
- b. In no event shall our total liability exceed the amount paid by the customer for the goods.

## 7. Intellectual Property

- a. Made For Trade Windows Ltd.'s business name, logo, and any other trademarks or intellectual property shall remain our exclusive property. The customer shall not use, reproduce, or modify our intellectual property without our prior written consent.

## 8. Governing Law and Jurisdiction

- a. This Agreement shall be governed by and construed in accordance with the laws of Scotland. Any disputes arising from or in connection with this Agreement shall be subject to the exclusive jurisdiction of the courts of Scotland.

## 9. Amendments

- a. Made For Trade Windows Ltd. reserves the right to modify or amend these Terms and Conditions at any time without prior notice. Any changes will be effective upon posting the revised Agreement on our website.
